DESCRIPTION
OF VIOLATION:

Willfully departed in a material respect from accepted trade standards for good and workmanlike construction as follows:

- 1) Contractor installed the aluminum patio threshold towards the house interior allowing water into the interior.
- 2) Contractor did not prepare the surface of the concrete slab/substrate within the 2x2 section of the guest bedroom to be even/level.
- 3) Contractor painted over the plastic ABS clean-out caps, creating a non-uniform unfinished appearance.
- 4) Contractor left paint roller marks in the guest bedroom ceiling (southwestern corner), creating a non-uniform unfinished appearance under normal lighting conditions.
- 5) Contractor did not seal the joint between the electrical outlet box and the plaster/stucco siding to prevent water intrusion.
- 6) Contractor penetrated/punctured the black paper building wrap and vertical portions of the metal weep-screed flashing with the fastener nails in the guest bedroom.
- 7) Contractor did not adequately nail the studs to the adjoining framing board and the top framing plate above the front door.
- 8) Contractor penetrated/punctured the black paper building wrap and the vertical portions of the metal weep-screed flashing in bedroom #1.
- 9) Contractor did not connect the electrical wire(hot) to the GFI outlet.
- 10) Contractor applied a non-uniform orange peel finish/texture on the east wall of the hallway.
- 11) Contractor did not apply a drywall mesh tape over the joint between the metal corner bead and the drywall ceiling in the garage.
- 12) Contractor did not install the toilet tanks leveled in the master bedroom and hallway.
